Re: Air Products – Erection of Air Separation Unit, Craigward Road, Alloa – Planning Application Ref. 22/00012/FUL – Notification of Continued Construction Works May 2024).

Dear Resident,

We are writing to inform you of the upcoming construction works relating to the Alloa, Air Separation Unit (ASU) construction project.

Air Products are planning to carryout weld non-destructive testing (NDT) on Sunday 2nd and 16th June 2024, 8:00am till 1:00pm.

This is to allow us to carry out weld inspections to required piping industry standards, to confirm pipe weld integrity. The team will consist of 2 NDT technicians, 1 supervisor and First aid cover for inspection of welds only. This work requires a high degree of skill and experience. Weekend work is required to reduce exposure levels to the Air Products and OI-Glass construction and operational teams. Additionally, the workforce attending is well-versed in these common testing procedures both for the sake of their own well-being and in order to ensure compliance with industry standards.

The works will generate no noise impact within the local area, conducted within an acoustic enclosure, and there are no deliveries taking place to impact the adjacent roads.

Arrangements are in place as per the previous weekend requests, including sound monitoring. As safety will always be Air Products top priority this allows us to follow established protocols to create a secure environment for all concerned, including residents, neighbours and our own site teams.

KEY POINTS:

1. Reduce personnel exposure levels during NDT inspections to a manageable level.
2. Eliminate exposure to OI-Glass personnel during normal working hours.
3. Eliminate noise exposure to residents and the public with local acoustic enclosures.
4. Maximum of 4 personnel on site carrying out the works.
5. No planned weekend deliveries impacting local road infrastructure.

We will maintain sound mitigation measures and monitoring to ensure there is no sound disturbance beyond the site boundary. The Site Liaison mobile phone will be left on site with the below contacts:
